4. Assigning MMSIs to autonomous vessels (self-propelled under 5 tons)

- Hull identification number 33 CFR 181 Subpart S
- Vessel numbering (<u>Part 173</u>), State numbering (<u>Part 174</u>) and Vessel Identification System (<u>Part 187</u>)
- Mayflower Autonomous Ship MMSI registration by ITU

USCG Boating safety handles hull numbers. Registration numbers, which are required for all powered vessels regardles sof size, could be obtained once a hull number is available and could be used for registration.

Shine asked what ship classification code should be used to identify autonomous vessel. Can only answer what the user thinks best. However it was later found that the Mayflower Autonomous Vessel used code XXX (unspecified). That code is probably what should be used if other indicators are inappropriate.

Bouy markers could be handled under FCC AIS fishing equipment proceding. USCG AIS Private AtoN process was discussed, where USCG assigns MMSI when approving

the AIS AtoN, and FCC then issues the necessary station license. USCG AIS Private AtoN process is described NAVCEN AIS FAQ 21 and Types of AIS – AtoNs.

SAR Aircraft MMSI problem was discussed. It was agreed the problem should be raised at ITU-R WP5B but action must be taken by IEC TC80 to update IEC 62288 where the problem occurs. A liaison from WP5B to IEC TC80 may be a way forward.

USCG and Army registrations of MMSIs may have largely been lost. For example, many were recorded on spreadsheets then lost when incumbents retired. Army is migrating MMSI registrations into PRMS JSETS (Joint SARSAT Electronic Tracking System).
